He went on to say that he could see her in her 8-year-old baseball uniform – the only kid on her team who could catch a fly ball. And how the coach concluded every pre-game warm-up by hitting high flies to his daughter to demonstrate to the others how it is supposed to be done. And she caught them all . . . well, almost all. He relived the one fly ball she misjudged. He heard again the awful thump of the ball hitting his daughter squarely in the nose. There was the gushing blood, the swollen face, and the rush to the hospital in Wilkes-Barre. He also remembered how he admired his little 8-year-old for both her courage and loyalty, deciding to leave her in the ER with her mother and return to the field to cheer on her teammates. His daughter continued over the years to blossom into a terrific baseball player, diving to catch line drives and hitting home runs even as the dads of her male teammates decided on members of the allstar team. She, according to her dad, was the best player out there but was never even considered. After all, she was a girl . . .

Recalling yet again, he reflected upon the fact that his daughter was so pretty and had a sparkling personality! And how she went through boyfriends almost weekly – so quickly, in fact, that after a while, he and his wife didn't even bother to learn their names anymore. They just called them all *Bud* and left it at that. Now, as he and his wife look upon her husband to be, standing nervously at the head of the aisle awaiting the arrival of his bride, they both could think back on all the trial versions of a mate their daughter had gone through before finding this man who is so obviously that right one. They could recall that whenever they liked one of her boyfriends, how she would get rid of him and take up with someone they simply could not stand – someone seemingly destined to become a serial killer, or worse. They had a sense of relief today that their daughter's idea of a partner and their idea of a partner for her had finally coincided!

As this father and daughter approached the altar, they later told me that they could hardly believe the journey from baptism to marriage had been such a brief moment in time. Life passes so quickly they said! The images in their minds came in rapid succession – like a fast slideshow on an iPhone. Each one brought back not only a memory, but even the sounds, smells and feelings of the moments both parents shared with their little girl. There was joy, and sorrow – laughter, and tears – hope and fear – a whole symphony of emotion that began to build into a mighty crescendo as this father and daughter arrived at the altar and Reverend Thompson began the service of marriage. The words of the service are the same words I have spoken probably 500 times over the forty-seven years of my ordained ministry, but one line still jumps out at me.

Who presents this woman to be married to this man?

This beautiful bride's father is hearing them for the first time . . .

Her mother and I do.

There is a lightning bolt of emotion that struck between father and daughter as they kissed one another, and dad subsequently placed his daughter's hand into her soon-to-be husband's. Then I concluded with the service of marriage. And looking at the bride's mother and father, I see tears streaming down their faces. Both parents had been experiencing such profound memories.

At the same time, Karin's and my eyes met. There was something sacred in that moment.

We all realized more deeply than ever that God had made two beautiful children who were now coming together to be husband and wife.

And there is no greater gift . . . and the greatest of these is love. (I Corinthians 13:13)



Trinity Presbyterian Church SPECIAL OFFERING FOR HEATING

Dear Members and Friends,

At the annual meeting on January 29, 2023, Karen Perzia, Treasurer, provided an overview of the 2023 budget. As you are aware, we have been confronted with increases in our family expenses. This is also true of the church. During 2022 our heating and electric bills increased by \$6,000.00. This would indicate that our 2023 utility budget projection would cost \$18,000.00. Heating and electricity is the church's largest single operating expense.

Our Property Committee and heating contactor (Newco) inspected all of the heating and air conditioning equipment and ensure us that they are operating at peak efficiency. The next area to examine is usage. One question frequently asked, do we allow the heat to run when the building is empty? We were advised that we should maintain a level heating setting. We shouldn't lower the heat after school too much. It would be more costly to bring the heat back up to standard recommended levels than to maintain a steady level all night. We do lower the heat in the sanctuary after the service on Sunday and turn it up the following Saturday night.

The Session has considered a number of solutions. The first one is a "Special Offering for Heating." This offering is truly a special offering that will be dedicated to the heat and electric bills. The congregation will be kept apprised of the results of this Special Offering.

Please consider giving as generously as you can. For your convenience, we will place special envelopes on the table outside the entrance to the sanctuary. If you place a check in the offering plate, please write in the memo section "Heating Fund." You may also mail your check to the church office.

Thank you for considering this request. We all want to be warm and comfortable when we attend worship services and events at our church. Your "Special Offering" will be greatly appreciated.
